Burglary Arrest

On 24 Jun 10 at approximately 0728 hours, Officer David Kaminski responded to an address in the 500 block of New Dauphin Street to investigate a report from neighbors of suspicious activity. Neighbors reported a red pick-up truck parked in the alley behind a residence in the block and two males removing items from the residence. Upon arriving in the block, Officer Kaminski observed that the vehicle and the two male subjects were gone. Officer Kaminski spoke with neighbors, and in an attempt to locate the property owner, contacted a Lancaster City Housing Inspector. Officer Kaminski learned that the property was under renovation.

Officer Kaminski spoke with other neighbors and learned that the suspicious subjects were observed entering and exiting the residence the day prior, placing items from the residence in their red pick-up truck. After leaving the area to file his report, Officer Kaminski was later advised by neighbors that the red pick-up truck and two subjects had returned and were behind the residence.

Officer Kaminski arrived and observed the two subjects and the red pick-up truck behind the residence. A neighbor identified the two subjects as the same two subjects who were going in and out of the residence earlier in the day. Officer Kaminski arrested the two subjects and transported them to the Lancaster City Police Station. One of the subjects was found to be in possession of a credit card belonging to the property owner on New Dauphin St.

As a result of Officer Kaminski's investigation, he charged the following:
