Drug Search Warrants

On 26 JUL 2011 at 0915hrs. The Lancaster City Bureau of Police served two simultaneous drug search warrants on the 400 block of E. Strawberry St. Both locations were single family homes, 441 E. Strawberry St. and 428 E. Strawberry St.

The search warrants were the result of a month long investigation into illegal street level drug sales in the area of 400 E. Strawberry St. The investigation was led by the department's Selective Enforcement Unit (SEU).

The investigation was launched in response to citizen complaints about "open air" drug dealing in the area. Routine patrols conducting in the area, along with video surveillance, confirmed the illegal drug activity.

During the warrant service nine (9) people were arrested on related drug offense and outstanding warrants.

Six (6) dogs were removed from 441 E. Strawberry St. and transported to the Lancaster County Humane League by the Lancaster City Dog Law Enforcement Officer.

Both 428 and 441 E. Strawberry St. have been condemned by the Lancaster City Housing Authority.
