### Drug and Fugitive Arrests

On August 8, 2009, at approx. 0957 hrs., Officer Shawn Sheckard observed a tan Oldsmobile Bravada commit a traffic violation in the area of West Walnut Street and North West End Ave. Officer Sheckard conducted a traffic stop of the vehicle and found two occupants in the vehicle. Officer Sheckard observed a clear sandwich baggie containing marijuana on the floor of the vehicle. Officer Phil Bernot and Officer Joseph Graczyk responded to assist Officer Sheckard with a search of the vehicle. Upon searching the vehicle the officers located three bales of marijuana, each weighing approx. 10 pounds. The bulk marijuana weighed approx. 30 lbs. total and was packaged for distribution. The officers also located additional packaging material and drug paraphernalia inside the vehicle, along with a pair of brass knuckles. The officers also located a loaded 9mm handgun inside the vehicle. Both occupants were taken into custody and were transported to the Lancaster City Police Department.

The officers determined that the passenger of the vehicle, who was identified as Aaron Maurice BAGLEY Jr., was wanted out of Baltimore County, MD on an outstanding warrant failing to appear for court for a drug case.

Charged by Officer Sheckard with Possession With Intent To Deliver Marijuana (F), Persons Not To Possess, Use, Manufacture, Control, Sell Or Transfer Firearms (F-2), Firearms Not To Be Carried Without A License (F-3), Possession Of Marijuana (M), Possession Of Drug Paraphernalia (M), Prohibited Offensive Weapons (M-1), Driving While Operating Privilege Is Suspended Or Revoked and Required Position Or Method Of Turning.

## **Drug and Fugitive Arrests**

Both defendants were arraigned by Magisterial District Judge Jiminez. LABOY was committed to Lancaster County Prison in lieu of \$200,000 bail. BAGLEY was committed to Lancaster County Prison in lieu of \$150,000 bail. BAGLEY will face extradition proceedings to return to Maryland for their charges. The investigation is continuing.
