Last seen wearing: black spandex pants, shirt unk.color, sandals

Above subject was last seen by family members on Friday evening, 9/25/09 at her residence, 324 Beaver St. At this point the whereabouts of COLON-TORRES is unknown.

Previously Updated information(2 Oct 09):

Lancaster City Police are continuing an ongoing investigation regarding the above missing person, Lydia COLON-TORRES. Lancaster City Police are also working in conjunction with the Manor Township Police, Lancaster County Coroner's Office, Lancaster County District Attorney's Office, and Lancaster County Detectives as part of an ongoing investigation regarding the discovery of the body of a deceased female found along the shore of the Susquehanna River along Route 441 near the intersection of Donegal St., Manor Township.

At this point, there is no confirmation that the body of the female found in Manor Township is that of the missing woman. All agencies are working together to determine the identity of the deceased female located in Manor Township.

UPDATED INFORMATION CONFIRMING IDENTITY OF DECEASED(5 OCT 09):

On the afternoon of Monday October 5th, the Lancaster County Coroner's Office notified the Lancaster City Bureau of Police, that the body found along the shore of the Susquehanna River in Manor Township, was in fact, that of the missing female, Lydia Colon-Torres. The Lancaster Bureau of Police continue to work with all of the above listed agencies on this investigation and again, anyone with information is asked to call either agency at the above numbers. Callers do not have to give their names to provide information.
