Prostitution Arrests

On Friday 18 MAR 2011 the Lancaster City Police Selective Enforcement Unit (SEU), Street Operations Group (SOG) and members of the Pennsylvania State Police (PSP) conducted a joint Prostitution detail in the southwest area of Lancaster City.

During the detail Police employed a female Undercover Officer who posed as a prostitute. As a result of the detail, five (5) male subjects were arrested for Criminal Solicitation of a Prostitute. In all five (5) arrests the Undercover Officer was offered money to perform a sexual act for the suspect.

It should be noted that 4 out of 5 suspects arrested during the detail are non-city residents. The Selective Enforcement Unit initiated the detail in continued response to observations made by concerned residents and business owners in the Water Street area.

Arrested during the detail are the following subjects. Photographs are available upon request.

Charged were:

- 1) Jeremy Richard VOGEL W/M/27
Resident of the 1st blk of North St., Washington Boro, PA
Charged With:
 - Fleeing and Eluding Police (X2) (Felony 3)
 - Criminal Solicitation Prostitution (Misdemeanor 3)
 - Escape (Misdemeanor 2)
 - Accidents Involving Attended Motor Vehicle (Misdemeanor 3)

Upon VOGEL being arrested for the Criminal Solicitation of a Prostitute he physically pulled away from a uniformed police officer (Escape) and fled in a utility van. While fleeing in the van, VOGEL struck an occupied motor vehicle (no injuries). During a second and separate attempt to stop VOGEL, he again fled in the utility van. Police did not pursue VOGEL as he fled in the van. VOGEL turned himself in to the Lancaster City Police at 2120hrs. after being contacted via telephone by police. VOGEL is being held for Arraignment.
