Shooting 500 blk Locust St-update

At approximately 11:49 pm on Friday, 20 August, 2010, Officers and Detectives from the Lancaster Bureau of Police responded to the 500 block of Locust Street for a report of shots fired. As they arrived in the area a second report to 911 was made indicating that a person was struck by the gun fire.

There were multiple people about in the area of the 500 block of Locust Street upon police arrival. An 18-year-old city man was located with gunshot wounds and was transported to a local hospital for treatment via an ambulance. The shooting scene was secured and evidence was identified. Multiple shell casings were located and recovered along with additional evidence. Detectives and Officers have been interviewing witnesses. Based upon the investigation thus far, this shooting does not appear to be a random act.

The condition of the victim is listed as stable. The lead investigator in this shooting is Det. Kurt Miller. Anyone having information regarding this shooting is encouraged to call 735-1780. Information can be given anonymously.

Shooting 500 blk Locust St-update

Arrest warrants were issued for all three individuals, charging them with Aggravated Assault.

At 7:45 a.m. August 24, 2010 members of the Lancaster City Bureau of Police, assisted by the Lancaster County Special Emergency Response Team (SERT) attempted to serve the arrest warrants and a search warrant at a residence in the 500 block of East End Ave. The wanted subjects were not at this location, however the search warrant was executed and evidence pertaining to the shooting incident was recovered inside the residence.

At approximately 2:00 p.m. this date, Robert Scott Woods surrendered to the Lancaster City Police at the city police station. He is currently being held for arraignment.

The remaining two suspects, Kyrel Woods and Kendall Foster are currently wanted for Aggravated Assault. They are considered armed and dangerous. Callers can remain anonymous and do not have to give their names.

All persons accused of a crime are considered innocent until proven guilty in court.
