On the evenings of 20 DEC 2011 and 21 DEC 2011 the Lancaster City Bureau of Police Selective Enforcement Unit (SEU), assisted by other officers, conducted a two day Warrants Sweep operation.

The focus of the warrant sweep was to arrest subjects wanted on Felony Criminal Warrants related to illegal drug activity.
